WE ARE RECRUITING — SERVICE USER REPRESENTATIVE

Are you an adult with lived experience of safeguarding services, living in Carmarthenshire, Ceredigion, Pembrokeshire or Powys whom can offer an informed perspective on the quality and delivery of Safeguarding services in the Mid and West Wales region?

The Mid and West Wales Regional Safeguarding Board for Adults (CWMPAS), is looking to recruit a service user representative to be a member of its Regional Executive Adult Board. This will be a pilot exercise over a 1 year fixed term period. Your role will ensure the perspective and voice of adults at risk is represented and considered in the business of the Board and your lived experience informs strategic objectives and plans.

Your role and responsibilities will include:

- To attend approximately four Regional Safeguarding Board meetings per year (virtual attendance can be facilitated).
- To attend other relevant regional meetings as appropriate and as agreed between you and the
- To adequately prepare for Regional Safeguarding Board meetings by reading board papers and agenda in advance of the meeting.
- To maintain the confidentiality of agenda papers, discussion and decisions made.
- To provide a service user perspective to the business of the Regional Safeguarding Board.
- To contribute to the development of plans and proposals, providing constructive input from a service user perspective.
- To provide a link between the Regional Safeguarding Board and other service users where appropriate.

You will report to the Regional Safeguarding Board Chair and will receive direct support from the Strategic Regional Safeguarding Manager for Children and Adults at Risk. Full Reimbursement of reasonable expenses can be claimed.

The role will require a basic DBS check to be undertaken.

Buttle UK is awarding grants of up to £2,400 to support children and young people in Wales who are facing significant challenges. These grants are designed to assist those who:

- Have experienced a recent crisis
- Are struggling with educational engagement and wellbeing
- Are living on a low income and facing financial hardship

The Chances for Children grants provide individually tailored support packages that address both the educational and wellbeing needs of the child or young person.

If you are applying for the first time, it is recommended to contact Buttle UK to discuss the case before submitting an application. Their goal is to keep the process quick and responsive, with application outcomes typically provided within five working days.

PUBLISHED CHILD & ADULT PRACTICE REVIEWS



The prime purpose of practice reviews is to identify any steps that can be taken by Safeguarding Board partners to achieve improvements in multi-agency practice. These contain lessons learned which should be disseminated, and any recommendation arising should be implemented so that the changes required result in children being protected from suffering or harm in the future.

SAFECALL: CONFIDENTIAL SUPPORT FOR YOUNG PEOPLE AND FAMILIES



SafeCall is a free, confidential, and anonymous helpline and support service dedicated to assisting young people and family members affected by issues such as missing persons, county lines, and criminal exploitation. The service is available by phone, text, or online chat from 9am to 11pm, seven days a week. To contact SafeCall, individuals can call or text 116000.

Training and Resources

SafeCall also offers training and support for professionals working with those affected by these issues and the Home Office has developed several resources to aid in the promotion of SafeCall's services. These include:

- Posters: Outlining the support available for young people, families, and professionals.
- Business Cards: Designed for young people to easily access support.

OLDER VICTIMS OF ECONOMIC ABUSE - FREE TRAINING

Hourglass offers resources and support for older victims of financial abuse. The regional Violence Against Women, Domestic Abuse, and Sexual Violence partnership is collaborating with them to provide training on addressing economic abuse faced by older victims. This training aims to address the specific barriers older individuals face and improve support across the region.

The project is also developing a Community Response model in Wales to support older individuals who are victims of financial abuse. The goal is to:

- Reduce the number of future victims and those at risk through awareness-raising and prevention work.
- Develop referral pathways to and from relevant organisations and agencies.
- Enhance older people's independence, confidence, and knowledge about protecting their finances.

This summer, Disclosure Barring Service (DBS), Wales Council for Voluntary Action (WCVA), the Mid and West Wales Safeguarding Board and Carmarthenshire/Ceredigion Association of Voluntary Organisations (CAVO) worked together to deliver a series of events across the region to help support organisations to deliver safe and effective safeguarding practice.

Events were supported and delivered by senior staff from the DBS Service, WCVA, the Mid and West Wales Safeguarding Board, alongside learning and development leaders from local authority training departments.

Training days consisted of three workshops focussed on:

- * Good practice in relation to Safeguarding Policies and Procedures These offered an opportunity to consider your own safeguarding policies, review current resources and consider organisational process around your DBS responsibility.
- * Safe Recruitment and the DBS (Disclosure and Barring Service) Offered an overview of how DBS and your organisation can effectively work together for Safer Recruitment, and where you may have a legal duty to refer to the DBS.
- * The National Safeguarding Standards Training Standard- These sessions supported mandatory required training requirements in line with the National Safeguarding Training and Development Standards.

Events have now been delivered across all four Mid and West Wales regions, with a concluding mop up session held online for those unable to attend in person.

Attendance was very positive, with approximately 75% of participants from the voluntary sector and 25% from the statutory sector. A full evaluation of the programme will now follow, aiming to assess how improved safer recruitment practices are being implemented across the region.



INVITATION TO LOUDFENCE EVENT IN SWANSEA



LOUDfence is a survivor-led initiative that provides a platform for those who have experienced abuse within faith-based settings or have been affected by it. It is open to everyone and aims to raise community and institutional awareness, challenging the silence and shame surrounding abuse, and supporting survivors by validating their experiences and celebrating the act of speaking out.

Archbishop Mark O'Toole and the Safeguarding Departments of the Catholic Dioceses of Cardiff and Menevia invite you to join their next LOUDfence event in Swansea. This event aims to raise awareness of abuse, acknowledge the harm it causes to individuals, families, and communities, and provide an opportunity for people of all faiths and none to come together in solidarity and support for those affected by abuse.

⇒ **Date:** Saturday, October 19th

⇒ Time: Noon

⇒ **Location:** St David's Church, St David's Place, Swansea

The event will begin with Mass celebrated by Archbishop Mark at St David's Church. Following the service, light refreshments will be available in the Church Hall, providing an opportunity for community and support networking. For those who might feel uncomfortable in the cathedral setting, a neutral room without ecclesiastical décor will be available.

What Happens at a LOUDfence Event?

LOUDfence events focus on tying brightly coloured ribbons and messages of support in public spaces, such as railings and fences, to show solidarity with all victims and survivors of abuse. Participants are welcome to tie ribbons and messages of support on the day of the event or during the following week, either to the railings or to the dedicated LOUDfence tree inside the church.

During the Swansea event, members of the Safeguarding Team, clergy, and laity will be available to offer support, guidance, and a listening ear to survivors and anyone with concerns about abuse in any context.

PRUDIC (PROCEDURAL RESPONSE TO UNEXPECTED DEATH IN CHILDHOOD) PROCESS: INFORMATION FOR FAMILIES

The unexpected death of a child is a profound tragedy for both the family and the wider community. To address this, it is crucial that all such deaths are carefully reviewed to prevent future tragedies and support the bereaved family, carers, and friends.

What is PRUDiC?


PRUDIC, or Procedural Response to Unexpected Death in Childhood, is the process that outlines how professionals in Wales should respond to the unexpected death of a child. This process ensures that the response is safe, consistent, and sensitive to the needs of the grieving family.

A series of leaflets have been created to provide clear information about the PRUDiC process for both parents and relevant professionals. These leaflets were developed by the National Safeguarding Service (NSS) on behalf of the NHS Wales Safeguarding Network. Recognising the need for clear communication, the leaflets were developed through consultation with parents who have lived experience, as well as health and education representatives.

Two leaflets have been produced: one for parents and carers, and another for professionals. These leaflets aim to clearly and compassionately explain the PRUDiC process to those affected by the unexpected death of a child.
